

CANDIDATE ELIGIBILITY REQUIREMENTS AND INSTRUCTIONS

FOR CANDIDATES WHO ARE PURSUING A DEGREE PROGRAM AT A COLLEGE OR UNIVERSITY

PROGRAM: Senior level (4th year) high school student and/or continuing college students intending on pursuing a degree program at an accredited college, or any higher level student at an accredited college or university.

FINANCIAL ASSISTANCE: Candidates who receive moneys from other sources are eligible to apply for this award. Financial need is only one of several criteria to be reviewed in determining the most qualified recipient.

RE: APPLICATION: Applicant and recipient may re-apply bi-yearly for scholarship award, provided a new application is submitted each time.

AWARD AMOUNT: Award will be in the amount of \$500/per semester for a total of \$1000. Award will be based on review of applications received. The CTAPWA reserves the right not to issue a scholarship if no submitted application/s are deemed to indicate a scholarship issuance is warranted.

DEADLINE: Applications must be postmarked by January 31, 2008, and submitted to the Branch Scholarship Committee Chairperson. Notification of award will be by letter on or about Feb 28, 2008. Please be sure to include an address and phone number where you can be reached during this time. Presentation / announcement of awards will be during a TPWA regular meeting TBA.

AWARD: The award check will be made payable to the student upon receipt of enrollment confirmation.

INELIGIBILITY: Active members of the CTAPWA Scholarship Committee and their family members are not eligible to apply.
