



Professional Manager of the Year Award Solid Waste

2010 TPWA Awards Program

Purpose	<p>The Professional Manager of the Year Award in the Solid Waste category seeks to inspire excellence and dedication in the private and public sectors by recognizing the outstanding career service achievements of solid waste management professionals. The primary focus of this award is recognition of exceptional management, operation, and maintenance of public sector solid waste operations.</p>
Eligibility	<p>Candidates must meet all the following criteria:</p> <ol style="list-style-type: none">1. Be an active member of TPWA whose primary responsibility is solid waste management.2. Must have 10 years of qualifying experience.3. Employed by either the public or private sector with career service in public sector solid waste operation.4. Must manage a significantly diversified solid waste operation, i.e. landfill, collection, incineration and recycling operations or a combination of those.
Selection	<p>The TPWA Awards Committee reviews the nominations and selects the award winner. Criteria will include:</p> <ol style="list-style-type: none">1. Significant contributions to the advancement of solid waste management.2. Outstanding leadership and vision evidenced by employing progressive management techniques in the area of solid waste management.3. Employment of new and innovative ideas and technology resulting in the advancement of the effectiveness of solid waste management.4. Implementation of effective methods solid waste operations.5. Maintenance of a high degree of satisfaction among customers and other stakeholders.6. Promotion of the field of solid waste management in the community, agency or customers served.
Nomination	<p>Nominations may be made by Texas Chapter members, a community organization, or a public agency. Original submittal should include the nomination form and the award's eligibility requirements. Seven copies of the submittal are required. These materials should be sent to the Texas Chapter Awards Chair (address can be found on the TPWA Website). Materials submitted in support of nomination will not be returned.</p>
Deadline	<p>May 1, 2010</p>
Presentation	<p>The winner is presented with a plaque at the Awards Banquet during the TPWA Annual Conference.</p>
